Show Date: “Art In The Park” will again be a **two day event**. It will take place at the lovely Vernon Square in Darien, GA from 10:00 AM – 5:00 PM on **Saturday, April 9th**, 2016 and 10:00 AM – 5:00 PM on **Sunday, April 10th**, 2016. No one should break down or remove any part of his/her display until 5:00 PM on Sunday.

Eligibility: All artists, 18 years and older, are eligible to submit original art work in the following

categories: **Painting** (oil, acrylic, watercolor, or pastel); **Sculpture**; **Photography**; **Drawing** (drawings, graphics & etchings); **Fine Crafts** (fiber art, pottery, jewelry & stained glass).
 All work must be for sale and priced with the intent to sell. This is a juried show. **All artists not previously juried by MAA must submit 3 (5" x 7") pictures of their work with their application.** If you wish these pictures returned to you, include a self-addressed, stamped envelope with your application package.

Application Deadline & Entry Fees: All applications must be received by **March 25th**. An entry fee of \$75.00 for MAA members or \$90.00 for non MAA members must accompany each application. **Applications received after this date must include additional late fee of \$20.** Those not accepted will be notified and the entry fee will be returned. All checks, money orders or cashier's checks should be made payable to McIntosh Art Association, Inc. and mailed along with application to MAA, P.O. Box 2103, Darien, GA 31305. There will be no refunds after March 25th 2016.

Space Specifications: Each exhibitor is allotted a 12' x 12' space. 10' x 10' tents are recommended. All exhibitors must furnish their own tents, tables, racks, chairs, etc. Tent spaces are assigned. ******Special space requests will be considered but not guaranteed.**

Awards: There will be a total of 5 awards. Overall First, Overall Second, Overall Third, Best In Show, and Best Booth. All awards except "Best Booth" are for Art entries. All categories might not receive an award. Prize packs will be given all winners and winners will be given an opportunity to display their art at the McIntosh Art Association Old Jail Art Gallery (dates to be scheduled).

Set Up and Break Down of Displays:

- All exhibitors must check in between 8:00 and 9:00 AM on Saturday morning and all exhibits must be ready by 10:00 AM
- Spaces will be assigned by 3:00 PM on Friday, April 8th and tents may be set up between 3:00 and 6:00 PM. *Note: We are seeking funds for security for Friday night, but we can't guarantee that at this time.*

Security: Security will be provided for Saturday night. MAA cannot be held responsible for any lost or stolen items.

Miscellaneous Rules and Information:

- This is a family oriented show and any work deemed unsuitable by MAA will be disallowed and removed from the show.
- Each exhibitor of a shared space must pay the full registration fee.
- Each exhibitor is responsible for collection and paying sales tax, if required.
- All vehicles must be removed from the park by 9:30 AM on Saturday, April 9th.
- Application Deadline: March 25th, 2016.
- No refunds after: March 25th, 2016.
- No breakdown before 5:00 PM Sunday.
- MAA membership is \$36.00 per year for individuals, \$50 annually for families. We hope you will all join in our fun.
