**Show Date:** "Affair at the Square" will be a **one day event**. It will take place at the lovely Vernon Square in Darien, GA from 10:00 AM – 5:30 PM on **Saturday, September 18th**, 2021. No one should break down or remove any part of his/her display until 5:30 PM.

**Eligibility:** All artists, 18 years and older, are eligible to submit original art work in the following categories:

**Painting** (oil, acrylic, watercolor, or pastel)

**Drawing** (drawings, graphics & etchings)

**Photography**

**Sculpture**

**Fine Crafts** (fiber art, pottery, jewelry & stained glass)

All work must be for sale and priced with the intent to sell. This is a juried show. **All artists not previously juried by MAA must submit 3 (5" x 7") pictures of their work with their application.** If you wish these pictures returned to you, include a self-addressed, stamped envelope with your application package.

**Application Deadline & Entry Fees:** All applications must be received by **September 10th**. An entry fee of \$50.00 for MAA members or \$60.00 for non MAA members must accompany each application. **Applications received after this date must include additional late fee of \$15.** Those not accepted will be notified and the entry fee will be returned. All checks, money orders or cashier's checks should be made payable to McIntosh Art Association, Inc. and mailed along with application to MAA, P.O. Box 2103, Darien, GA 31305. There will be no refunds after September 10<sup>th</sup>, 2021.

**Space Specifications:** Each exhibitor is allotted a 12' x 12' space. 10' x 10' tents are recommended. All exhibitors must furnish their own tents, tables, racks, chairs, etc. Tent spaces are assigned.

**\*\*\*\*Special space requests will be considered but not guaranteed.**

#### **Set Up and Break Down of Displays:**

- All exhibitors must check in between 8:00 and 9:00 AM on Saturday morning and all exhibits must be ready by 10:00 AM
- Spaces will be assigned between 4:00 and 6:00 PM on Friday, September 17th and tents may be set up that evening .

**Security:** Security will be provided for Friday night. MAA cannot be held responsible for any lost or stolen items.

#### **Miscellaneous Rules and Information:**

- This is a family oriented show and any work deemed unsuitable by MAA will be disallowed and removed from the show.
- Each exhibitor of a shared space must pay the full registration fee.
- Each exhibitor is responsible for collection and paying sales tax, if required.
- All vehicles must be removed from the park by 9:30 AM on Saturday, September 18th.
- Application Deadline: September 10th, 2021
- No refunds after: September 10th, 2021.
- No breakdown before 5:30 PM Saturday.
- MAA membership is \$35.00 per year for individuals, \$50 annually for families. We hope you will join in our fun.
